Balloting will be used to determine the order of priority. Persons interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

- 1. Each of the registrants (if the registrant is a company, then any one of its directors) must submit personally
 - (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted;
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) shall in any event not exceed five (5). Each cashier order shall be in the sum of HK\$300,000 and made payable to "DEACONS"; and
 - (c) a copy of the registrant's H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate

- 2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the residential property(ies).

After the completion of the balloting and selection of the residential properties by the eligible registrant(s), the order of priority in the selection of the remaining residential properties will be on a first come first served basis.
