#### On 25 October 2013 ("the first date of the sale")

Balloting will be used to determine the order of priority. Persons interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

- 1. Each of the registrants must submit
  - (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted:
  - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event (for all registrant(s) who are Hong Kong permanent residents) shall not exceed three (3) or (in other cases) shall not exceed one (1). Each cashier order shall be in the sum of HK\$300,000 and made payable to "DEACONS": and
  - (c) a copy of the registrant's H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate
  - to 86/F International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong during 21 October 2013 to 23 October 2013 (from 11:00 am to 8:00 pm).
- 2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the residential property(ies).
- 3. The balloting will take place at 11:00 am on 24 October 2013 at 86/F International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong ("designated venue"). Every Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent. The ballot results, including "registration number", "ballot result sequence" and "check-in timeslot for registrants" will be posted by the Vendor at the designated venue at 4:00 pm on 24 October 2013. Registrants will not be separately notified of the ballot results.
- 4. On the first date of the sale, successful registrants (if the registrant is a company, then all of its directors) shall personally attend the designated venue according to the "check-in timeslot for registrants" posted by the Vendor. Successful registrant must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and the receipt of Registration of Intent. Successful

registrant(s) who arrives at the designated venue beyond the "check-in timeslot for registrants" shall not be eligible to select and purchase the specified residential properties.

- 5. After verification of the identity of the successful registrants, the successful registrants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the "ballot result sequence". However, only those registrants who satisfy the following requirements:
  - (a) each of the registrants of a Registration of Intent is a Hong Kong Permanent Resident(s) ("HKPR"); or
  - (b) one or more of the registrants of a Registration of Intent is a HKPR who purchases the specified residential property(ies) jointly with one or more close relative (i.e. spouse, parents, children, brothers and sisters) who is/are not HKPR but is/are a registrant(s) of that Registration of Intent

will be entitled to select (but not more than three (3) residential property (for the registrant(s) of each Registration of Intent who satisfy the requirement in sub-paragraph (a) above) or not more than one(1) residential property (for the registrant(s) of each Registrant of Intent who satisfy the requirement in sub-paragraph (b) above) the following residential properties:

- 6. If a registrant has successfully selected any of the residential properties, the registrant will be offered to view the selected residential property(ies) and if the registrant decides to purchase the selected residential property(ies), the registrant will enter into a Preliminary Agreement for Sale and Purchase of the residential property(ies) (if the registrant is a company, then all its directors should sign the Preliminary Agreement for Sale and Purchase for and on behalf of the Registrant).
- 7. If a registrant has not purchased any residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection by the registrant in person or by authorized person at 86/F International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong during 26 October 2013 to 27 October 2013 (from 11:00 am to 8:00 pm). The Registrant or the authorized person (if applicable) must bring along the H.K.I.D. Card(s) / Passport(s) of the registrant (or a copy of the H.K.I.D Card(s)/Passport(s) of the Registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate of the Registrant, the receipt of Registration of Intent, and (if applicable) a valid authorization letter and a copy of the H.K.I.D Card/Passport of the authorized person.

After the completion of the balloting and selection of the residential properties by the eligible registrant(s), the order of priority in the selection of the remaining residential properties will be on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

The Vendor also reserves its absolute right to adjust the time of balloting in view of the progress of carrying out any procedures relating to the sale.

#### On 26 October 2013 and thereafter:

First come First served. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing.

### 2013年10月25日("該首日出售日期"):

以抽籤方式決定選擇住宅物業的次序,有意購買該等指明住宅物業的人士(下稱「登記人」)須遵從下列程序:-

- 1. 登記人須於 2013 年 10 月 21 至 2013 年 10 月 23 日(上午 11 時至晚上 8 時內)到香港九龍柯士甸道西 1 號 環球貿易廣場 86 樓遞交
  - (a) 已填妥及由登記人簽署的購樓意向登記表格,每位登記人只可遞交 1 份購樓意向登記,重複遞 交將不會受理,
  - (b) 購樓意向登記表格須附有本票,本票的數目需與登記人於購樓意向登記表格內填寫的意欲購買的住宅物業數目相同,惟該住宅物業數目(如所有登記人均是香港永久性居民)不能多於 3 個或(如屬其他情況)不能多於 1 個。每張本票金額為港幣\$300,000 及抬頭人須為「的近律師行」;及
