(II) Procedures for Session A

1. Balloting will be used to determine the order of priority. Eligible persons interested in purchasing any two of the specified residential properties (“**Form A Registrant**”) that will be offered to be sold in Session A must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II) and (IV) of this Sales Arrangement.

2. Form A Registrant must submit the following:-

- (a) only one Registration of Intent (Form A) duly completed and signed by the Form A Registrant;
- (b) Registration of Intent (Form A) shall be accompanied with two (2) cashier orders. Each cashier order shall be in the sum of HK\$500,000 and made payable to “DEACONS”; and
- (c) a copy of the Form A Registrant’s H.K.I.D. Card(s)/Passport(s)

to the designated venue after relevant price lists of the specified residential properties are made available till 28 March 2015 during office hours (from 11:00 a.m. to 8:00 p.m. from Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and public holidays, except for 28 March 2015 the office hours will be from 11:00 a.m. to 4:00 p.m.). The closing time for submission of Registration of Intent (Form A) will be 4:00 p.m. on 28 March 2015. Late submission or submission outside the office hours will not be accepted.

3. Balloting will take place in batches:-

(a) First round balloting for this Session (for dividing all Form A Registrants into one or more group(s))

- (i) The first round balloting for this Session will take place at or after 5:00 p.m. on 28 March 2015 at the designated venue for the purposes of dividing the Form A Registrants into one or more group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the designated venue. Form A Registrants will not be notified separately of such changes.
- (ii) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at the designated venue after completion of the first round balloting. Form A Registrants will not be separately notified of the ballot results.
- (iii) Form A Registrants in each group will be eligible to participate in the second round balloting as detailed in paragraph 3(b) below.

(b) Second round balloting (for determining the order of priority of Form A Registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting for the group(s) of Form A Registrants will take place on 29 March 2015 in batches at the designated venue at the beginning of the relevant “check-in timeslot for each group” as posted by the Vendor pursuant to paragraph 3(a)(ii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the designated venue. Form A Registrants will not be notified separately of such changes.
- (ii) For the purpose of verification of identity, Form A Registrants must bring along his/her/their original H.K.I.D. Card(s)/Passport(s) and the original receipt of the valid Registration of Intent (Form A) and **personally** attend the designated venue according to “check-in timeslot for each group” posted by the Vendor. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the second round balloting, make use of the lobby on 3/F and/or 10/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (the “**Additional Venue**”) to accommodate some of the Form A Registrants by making announcement and/or posting notice(s) at the designated venue and the Additional Venue. Form A Registrants who arrive at the designated venue or (if directed by the Vendor) the Additional Venue beyond their “check-in timeslot for each group” shall not be eligible to participate in this Session.
- (iii) For the purpose of the second round balloting, every Registration of Intent (Form A) shall be allotted one lot. The results of the second round balloting, including “registration number” and “ballot result sequence” will be announced and/or posted by the Vendor at the designated venue and the Additional Venue (if

applicable). Form A Registrants will not be separately notified of the ballot results.

4. (a) Immediately after the second round balloting, Form A Registrants shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time. The Form A Registrants shall in compliance with the rules set out in the Abstract in Section (I) above select and purchase 2 specified residential properties, otherwise his/her/their order of priority shall lapse automatically and he/she/they will no longer be eligible to participate in this Session.
  - (b) However, if the Form A Registrant (“**first registrant**”) together with another related Form A Registrant with lower order of priority than the first registrant (“**second registrant**”) (with each individual comprised in the second registrant being the close relative (i.e. spouse, parents, children, brothers and sisters) of each individual comprised in the first registrant, subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final) intend to select and purchase **four (4) Units on the same floor in the same Zone of the same Tower**, then the second registrant may be promoted to have the same order of priority as the first registrant. In such circumstances, the second registrant’s original order of priority shall lapse automatically. The first registrant and the second registrant must select and purchase four (4) Units on the same floor in the same Zone of the same Tower, otherwise their order of priority shall lapse automatically and they will no longer be eligible to participate in this Session.
5. Prior to the signing of the Preliminary Agreement(s) for Sale and Purchase, the Form A Registrant will be offered to view the selected specified residential properties. Form A Registrant shall **personally** enter into one or more Preliminary Agreement(s) for Sale and Purchase of the selected specified residential properties (except that **the purchase of Units A and B on the same floor in Tower 20 Zone 1 must be under one Preliminary Agreement for Sale and Purchase**).

(III) Procedures for Session B

6. Balloting will be used to determine the order of priority. Eligible persons interested in purchasing any of the specified residential properties (“**Form B Registrant**”) that will be offered to be sold in Session B must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (III) and (IV) of this Sales Arrangements.
7. **Form B Registrants are reminded that all Units B in Tower 20 Zone 1 will not be offered for sale in Session B and if all the specified residential properties in Tower 20 Zone 1 (except all Units B in Tower 20 Zone 1) are sold out in Session A, there will not be any specified residential properties in Tower 20 Zone 1 offered for sale in Session B.** The Vendor may postpone the commencement of Session B pending completion of Session A. Form B Registrants will not be separately notified of such change.
8. Form B Registrant must submit the following:-
  - (a) only one Registration of Intent (Form B) duly completed and signed by the Form B Registrant;
  - (b) Registration of Intent (Form B) shall be accompanied with one (1) cashier order in the sum of HK\$500,000 and made payable to “DEACONS”; and
  - (c) a copy of the Form B Registrant’s H.K.I.D. Card(s)/Passport(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary

to the designated venue after relevant price lists of the specified residential properties are made available till 28 March 2015 during office hours (from 11:00 a.m. to 8:00 p.m. from Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and public holidays, except for 28 March 2015 the office hours will be from 11:00 a.m. to 4:00 p.m.). The closing time for submission of Registration of Intent (Form B) will be 4:00 p.m. on 28 March 2015. Late submission or submission outside the office hours will not be accepted.

9. Balloting will take place in batches:-
  - (a) First round balloting for this Session (for dividing all Form B Registrants into one or more group(s))
    - (i) The first round balloting for this Session will take place at or after 5:15 p.m. on 28 March 2015 at the designated venue for the purposes of dividing the Form B Registrants into one or more group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the designated venue. Form B Registrants will not be notified separately of such changes.

- (ii) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at the designated venue after completion of the first round balloting. Form B Registrants will not be separately notified of the ballot results.
  - (iii) Form B Registrants in each group will be eligible to participate in the second round balloting as detailed in paragraph 9(b) below.
- (b) Second round balloting (for determining the order of priority of Form B Registrants in selecting and purchasing specified residential properties)
- (i) The second round balloting for the group(s) of Form B Registrants will take place on 29 March 2015 in batches at the designated venue at the beginning of the relevant “check-in timeslot for each group” as posted by the Vendor pursuant to paragraph 9(a)(ii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the designated venue. Form B Registrants will not be notified separately of such changes.
  - (ii) For the purpose of verification of identity, Form B Registrants must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of the valid Registration of Intent (Form B) and **personally** (if Form B Registrant comprises corporation, then **all directors** of that corporation) attend the designated venue according to “check-in timeslot for each group” posted by the Vendor. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the second round balloting, make use of the Additional Venue to accommodate some of the Form B Registrants by making announcement and/or posting notice(s) at the designated venue and the Additional Venue. Form B Registrants who arrive at the designated venue or (if directed by the Vendor) the Additional Venue beyond their “check-in timeslot for each group” shall not be eligible to participate in this Session.
  - (iii) (For Form B Registrant comprising corporation(s)) If after the submission of Registration of Intent (Form B), there is any change in the composition of the board of directors of the corporation(s), then the relevant Registration of Intent (Form B) shall become invalid immediately and the Form B Registrant shall not be eligible to participate in this Session.
  - (iv) For the purpose of the second round balloting, every Registration of Intent (Form B) shall be allotted one lot. The results of the second round balloting, including “registration number” and “ballot result sequence” will be announced and/or posted by the Vendor at the designated venue and the Additional Venue (if applicable). Form B Registrants will not be separately notified of the ballot results.

10. Immediately after the second round balloting, Form B Registrants shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time. The Form B Registrants shall in compliance with the rules set out in the Abstract in Section (I) above select and purchase 1 specified residential property (except all Units B in Tower 20 Zone 1), otherwise his/her/their order of priority shall lapse automatically and he/she/they will no longer be eligible to participate in this Session. Prior to the signing of the Preliminary Agreement for Sale and Purchase, the Form B Registrant will be offered to view the selected specified residential property. Form B Registrant shall **personally** enter into a Preliminary Agreement for Sale and Purchase of the selected specified residential property.

(IV) General Procedures

- 11. Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent (Form A) and/or one valid Registration of Intent (Form B). Duplicated registration in a Session will not be accepted. The Registration of Intent (whether Registration of Intent (Form A) or Registration of Intent (Form B)) is personal to the registrant and shall not be transferable. The order of submission of the Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent (whether Registration of Intent (Form A) or Registration of Intent (Form B)) is valid and should be included in balloting.
- 12. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
- 13. The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

14. (For registrant comprising individual(s) only) Before signing the Preliminary Agreement for Sale and Purchase, a registrant may notify the Vendor on spot to add and/or delete the name(s) of individual(s) signing the Preliminary Agreement for Sale and Purchase, provided that:
- (a) if a Form A Registrant wishes to delete any name(s) of individual(s), then prior to deletion of any name(s) of individual(s) all the individual(s) comprised in the Form A Registrant must be the close relative(s) of each other (i.e. spouse, parents, children, brothers and sisters) and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final;
  - (b) the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant (i.e. spouse, parents, children, brothers and sisters) and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.

All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant's request to add and/or remove any individual.

15. If a registrant has not purchased any specified residential property, his/her/their unused cashier order(s) will be available for collection by the registrant (or his/her/their authorized person) at the designated venue from 30 March 2015 to 31 March 2015 during office hours (from 11:00 a.m. to 8:00 p.m. from Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and public holidays). The registrant must bring along his/her/their H.K.I.D. Card(s)/Passport(s) (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if unused cashier order(s) is/are collected by authorized person), (if applicable) copy of Business Registration Certificate, the original receipt of valid Registration of Intent (Form A)/Registration of Intent (Form B), and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.
16. After the completion of the balloting and selection of the specified residential properties by the eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing, provided that Unit B in Tower 20 Zone 1 must be purchased together with Unit A on the same floor in Tower 20 Zone 1 and they must be purchased under one Preliminary Agreement for Sale and Purchase. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).
17. The Vendor reserves the right to close the designated venue and the Additional Venue (if applicable) at any time if all the specified residential properties (except all Units B in Tower 20 Zone 1) have been sold out.
18. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 8:00 p.m. on the date on which Registration of Intent may be submitted, the first round balloting (for Session A and/or Session B) will take place and/or the first date of the sale, then, for the safety of the registrants and the maintenance of order at the designated venue and/or the Additional Venue (if applicable), the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Registration of Intent, the first round balloting and/or second round balloting (for Session A and/or Session B) and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the designated venue and/or the Additional Venue (if applicable). Details of the arrangement will be posted by the Vendor on the website ([www.thecullinan.com.hk](http://www.thecullinan.com.hk)) designated by the Vendor for the Phase. Registrants will not be notified separately of the arrangement.

**On 30 March 2015 and thereafter:**

19. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties, provided that Unit B in Tower 20 Zone 1 must be purchased together with Unit A on the same floor in Tower 20 Zone 1 and they must be purchased under one Preliminary Agreement for Sale and Purchase. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting).
20. The Vendor reserves the right to close the designated venue at any time if all the specified residential properties (except all Units B in Tower 20 Zone 1) have been sold out, provided that the designated venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 15 above.
21. If the Vendor postpones the first date of the sale to such other date pursuant to this Sales Arrangements, the subsequent dates of sale will be postponed accordingly.
22. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 8:00 p.m. on any date of sale (other than the first date of the sale), for the safety of the registrants and the
