Balloting will be used to determine the order of priority. Persons interested in purchasing any of the specified residential properties (the "Registrant") must follow the procedures below:-

- 1. For the avoidance of doubt, all valid Registrations of Intent (if any) previously submitted to the Vendor prior to the first date of sale will not be included in this balloting.
- 2. Registration slips will be distributed at designated venue on the first date of sale (from 11:00 a.m. to 11:15 a.m.)("check-in timeslot"). A Registrant (if the Registrant comprises corporation, then all directors of that corporation) must **personally** attend the designated venue and submit the following:-

After the balloting, Registrants shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot result sequence and in an orderly manner and within reasonable time. Prior to the signing of the Preliminary Agreement for Sale and Purchase, the Registrant will be offered to view the selected specified residential properties. All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the Registrant's request to add and/or remove any individual.

Card(s)/Passport(s)(or a copy of the H.K.I.D Card(s)/Passport(s) of the Registrant if unused cashier order(s) is/are collected by the authorized person), (if applicable) copy of Business Registration Certificate, the original receipt of valid registration slip, (if applicable) a valid authorization letter and a copy of the H.K.I.D Card/Passport of the authorized person.

- 10. After the completion of the balloting and selection of the specified residential properties by the eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing and the balloting procedures stated above will not be applied to the purchase of such remaining specified residential properties.
